Jason Kern visited my parents on around 5th Nov. He told them "How do me and Daniel stop this, it's all Bullshit!" He got the phone number & rang the police, their reaction was to threaten my parents that they (Kerns C.I.B.) would actually prosecute my family (Parents) for interfering with a witness (my parents work for the police, Arzavie community constables office) when it was Jason who went to them. Daniel Ball, & Jason Kern Parents both named on affidavit re conspiracy to defraud A.C.C. among others. "Holmes" show, Fri 13th Nov., Jason Ng publicly lied about things allegedly done by me, which he & Steven Higgins did. There was not alcohol provided for the purpose of getting anyone drunk, there was no alcohol provided at all. The reason the house was repainted, and in poor/dirty condition, was that Ng, Bateman & others destroyed it upon my arrest. The room downstairs, as shown, was the room in which Scott Bateman molested Jason Kern. The program said that last year I complained about the Kyrre school & those complaints were unfounded. I received letters telling me that the school was under investigation, & that changes were being made. (D.S.W. & Commissioner for children). Ng showed wrong room for sex games. It should have been the small room, his room. I caught him red handed, in there, & stopped him. There was a set of brown steel bunk beds in there & green carpet.

Jason Kern went to Douglas Finlayson approx 1st or 2nd Nov. told him he'd run away from home and wasn't going back because they (his mum & other, police etc) kept telling him what to say

Leonie Gutsell (Shannon Williamson) 496
(BENEFIT FRAUD).

During the last few years, Leonie Gutsell has been living with Jeff Reece. She was on the P.P.B. He was either working, or on the unemployment Benefit. Sometimes both. Unemployed - and working at B.P. garage at the corner of Sparks Road and Moon Hay Road. They lived in Dencin Place for awhile, then moved to 5 Myers place Moon Hay. Geoff began working as a butcher, and at the B.P. garage Leonie stayed on the benefit for quite some time. Recently, she went off the P.P.B. They have moved to 465 Hereford St DC they were worried that Tony Williamson would "Mark them off". They knew that I knew, Leonie kept hinting that "anyone who marked" would get "wasted".

The day of my arrest, Leonie & Geoff came around. It was a social visit. I ~~mentioned~~ told her that I had been accused of molesting "all the boys I ever knew", by Scott Batdela, Jason P & Matt were there (the board when she visited, the whole time. She said "that means they'll probably question Shannon". I told her that they would, and assured her that we had not been molested by me, which was entire true. She said "Oh no, I don't know what I'll say, he got in a few shittys in the last few weeks; A girl at the family home was running around saying 'Shannon fucks his mother' so he's likely to say anything, Hilda Bradley had told her this. Hilda Bradley → Barry Hunt → Linda Hunt → Sharon Gifford complainant". She then said "Shit he's likely to say anything".

Shannon reported to me that Michael Dunschick "did rude things" to him when he was staying with Shannon & his parents last year. He wouldn't elaborate, I didn't push it.

Last year, ^{on 1999} Toni + Trevor Lilley, was physically abused by Toni Lilley. A police complaint was laid and the incident was witnessed by Graham's sister Marie. Trevor and Toni Lilley told Graham that they would tell the police that I was "gay with boys" if he went ahead with his complaint. Graham thought that protecting me was the right thing to do, even though he knew nothing had happened and it was a bluff. But Les Lilley talked him into believing it and he withdrew the complaint. He didn't want to lose me, and should have carried out the complaint. ~~since~~ He didn't know they were bluffing. Since, he has wanted to reinstate the complaint as he is very disturbed by the constant abuse he suffered at the hands of Trevors wife, and former girlfriend Janice Pire.

Jason Ng + Scott Batchelor went to Trevor + Toni's and told them I'd molested Michael now (23) + Graham Lilley (13). They laid a complaint. They also told him that I'd accused Trevor of "slandering" Graham last year. That referred to the assault by Toni Lilley on Graham. Ng + Batchelor lied about the context.

* The complaint was that I'd molested Graham, Michael (Trevors nephew), and David Lilley. I is entirely untrue.

Police spoke to Graham in Wellington. His mother spoke to me about it. Graham told the police that I had never touched him sexually, and that he had neither seen or heard of me touching anyone else sexually. He lived with me for about 9 months, and stayed nearly all weekends, so he'd know if anything went on. Graham's mother said that police told them that I was guilty, that I said I'd molested him.

Linda Hunt

When living in Cosbet St Udd, Linda Hunt was on the D.P.B., and had a boyfriend living with her. His name is Shane. He was on the unemployment benefit. They had a white house together, it was large and Linda was venting out the other side to a Deidre Sergeant at \$65/week. Deidre and Shane came from Whangarei. She then moved to Fitzgerald Ave with him. I ~~believe~~ she is now in a flat in Woodham Road Christchurch. I have been there. Shane still lives with her. I do not know if she has ceased D.P.B., or if so, at what point in the past 3 years since going back in Christchurch. I stress the word rent, to do with Castel street. The house was divided into two flats. She rented the whole house, and rented one flat out. The flats had separate power etc. Shane only stayed with me twice. Both times with Jason King was there. They slept in the spare room. Both of them. I believe that Linda saw the opportunity of big money & went for it. I did not touch him at all.

HICKERMAN - BENEFIT FRAUD 440

Henry Akkerman has worked for McIvor
 metals in Addington for at least 18 months. He
 has been collecting an invalids benefit, as well
 some weeks, he had delivered a van load of
 copper wire (he stripped it himself), sumps and other
 aluminium parts of cars in 46 gallon drums, and
 brass bits of motors & electric things etc, and received
 hundreds of dollars ^{in one week or so}. His son Andrew went with
 him in the mornings before school. He was given
 part of the money (only \$5.40). When Henry went
 to McIvor Metals, I believe the receipts etc were
 made out to "HENRY", or "HENRY AKKERMAN",
 often just his first name was written to put
 off anyone who came to investigate, since
 allegations had been made once that he was
 working and on a benefit, he was given van
 loads of scrap to strip, to get only the
 Aluminium, copper etc. He was paid by McIvor
 metals to do it. He did say how much per
 kilo it was but I can't remember. Last year
 someone complained to the housing corp that
 Henry was doing a business from home. He
 was told to clean it all up in one week.
 He used to burn off wire to strip it. But
 was told it was illegal, so he went out to
 the Waimakariri River to burn it off instead.
 He often took Andrew with him. He made
 from \$30 up per day, often more. The
 last time I was there, he was still ^{2 months} working.
 He said he wasn't getting enough money on the
 benefit. He used to use a Hillman theater station
 wagon, but that became too small and he changed
 to a Bedford CF commercial last year. He had
 Russell Kirk from next door to him in
 Leicester Crescent working with him to cope
 with the amount of work. As far as I know,
 he has been doing it for around 3 years or
 longer. McIvor Metals keep records of all transactions
 but I know it's at least 18 mths.

He picked up scrap from various rubbish dumps. One was in Springs Rd on the corner by the car wreckers.

Further to Alkenman. I, and my boys, have on occasions received phone calls from Andrew Alkenman, while he was being abused by his father. Once he said his father was "smashing" him up and he was very afraid. I have seen this happening to Andrew by his father. I saw Henry punch Andrew in the face, causing him to cry. This was around three months ago at my place, 12 Congilly Pl., when Henry had arrived to pick up Andrew. Other times Henry had punched Andrew, causing his nose to bleed on several occasions. Margaret, Henry's wife could not stop what was happening. She told me that Henry was responsible for all the children getting into trouble and fighting with each other, stealing etc. I had gone over to help her out last year, Scott stabbed someone on the Road outside the Alkenmans house. Henry was extraordinarily possessive of Andrew, and when he wouldn't go with him etc he would fly into a rage and beat the hell out of him. One night I, Jason Dg etc went over because Henry had beaten Andrew up. Andrew had barricaded himself in his room and was threatening to kill himself. Jason Dg broke in through a window and spoke to him for a long period. He was terrified of his father because of his violence and "other things" that he would not say.

Jan McWhinter was called by me earlier this year. She had questioned Andrew as to his home life, and although ~~he~~ ^{was wrong} said nothing, she knew that something was wrong. I told her how Andrew rang on quite a few occasions for help because his father had attacked him. We went over a few times. Andrew was always asking to come and stay, but each time he got home, his father asked a lot of questions. He often asked if anyone here (my place) was molesting him, this happened last year, this year, when Henry accused Russel Kirk from next door. Henry ~~was~~ ^{is} fanatical about Glen Elg health camp ~~and~~ ^{suggesting} him (Henry) of molesting his children. He often brought it up. It was a frequent topic of discussion. He would (Andrew) have violent outbursts against his father, and smashed things up. It was always to do with his father. Andrew only calmed down when I got there, and always wanted to come home with me and the others.

He (Andrew) on several occasions told his father, "You're not my father, Tony's my father. You're just a dirty old cunt". Henry told me this on at least four occasions. Some of the others heard it too. He was always sad to go home and cried. Andrew has been staying over a period of 3 years or so. He and Jan's kids are great friends. Andrew has stayed at Jan's a few times. Why did Andrew say that nothing ^{was} wrong at home, when he had been ^{approached} injured by his father with weapons, getting a bleeding nose from this. on several occasions. Why did Henry's wife ask me to tell her how to stop Henry hurting the kids.

Why did Henry, often have the boys sleep with him? (ask his wife) Henry is a very violent man. Did he pressure, on ~~career~~ Andrew to lie, to cover sinister aspects of his own. Was this why Andrew rebelled against Henry so wildly. Why did Andrew always want to leave home. When distressed, he always rang me.

Andrew suicidal on several occasions, to calm him down, he always came home with me. and didn't want to go home

ANN Marie O'Donnell.

Kyle stayed about 3 ~~and~~ weekends while his mother went out boozing. He was very disturbed, obnoxious, destructive and insulting. He was not molested by me, or anyone else. His mother used constant violence on him, health brough, axe handle etc, causing him injuries. Margaret Kern, the sister Susan & Glenis Ball witnesses. The DSW were involved (Carol Rennie) Ann Marie is close friends of the above. Kyle is very disturbed and has very serious problems with reality (see D.S.W. record). The police told me Kyle (8 one) (6 at the time of alleged sexual abuse) vomitted after describing things that I'd allegedly done. I'm not surprised at this; He lied and he knows it. Ann Marie has Kyle in care at weekends. He goes to Cl Cl East school. A close friend of Steven Gifford & Jason Kern (Complainants). He is very hard to handle. Apart from 3 weekends, he has not stayed again. I wouldn't have him. While at my home, he slept in the same room with Jason Kern, & Daniel Ball. He goes off into his own little world completely, I sometimes think he's Autistic.
